Reservations for this tour require a deposit of \$750 for the main tour and \$250 for the Mt. Kitanglad extension. Payment in full is due 4 months prior to the start date of your first tour.

All cancellations must be notified in writing. Emails are acceptable.

If notice of cancellation is received 6 months or more before your start date, your deposit is fully refundable.

If notice of cancellation is received between 4 and 6 months of your start date, 50% of your deposit will be refunded.

If notice of cancellation is received less than 4 months before your start date, you will not be entitled to any refund of deposits.

If cancellation occurs after full payment is made, a refund will be given only if the vacant spot is filled.

Trip Cancellation Insurance is strongly recommended. Should you become ill or injured while in Africa, medical costs will not be covered by your US health insurance policy. The cost to transport you home, should that become necessary, would be tens of thousands of dollars.
