Payment in full is due on or before July 30, 2022 (July 22 if registered for Rwanda – cancellation dates depend on your start date, 22nd if you are starting in Rwanda, 30th if you are starting in Uganda).

All cancellations must be notified in writing.

If notice of cancellation is received before May 22 or 30, 2022, your deposit is fully refundable.

If notice of cancellation is received between May 22 or 30 and July 30, 2022, 50% of your deposit will be refunded.

Cancellations received after July 22 or 30, 2022, are not entitled to any refund of deposits.

If cancellation occurs after full payment is made, a refund will be given only if the vacant spot is filled.

Trip Cancellation Insurance is strongly recommended.
